

FIRST AMENDMENT
TO CONTRACT FOR DELINQUENT ACCOUNT
COLLECTION SERVICES

THIS AMENDMENT (the "Amendment") is entered into as of this ____ day of November, 2013, by and between Client Services, Inc. (hereafter "CSI"), and the City of Bryan, a Texas home rule municipal corporation (hereafter "the City").

WHEREAS, CSI and the City are parties to an Agreement dated August 2, 2011, (the "Agreement"), wherein CSI identifies it will provide certain professional services on behalf of the City; and

WHEREAS, CSI and the City mutually desire to amend the Agreement to modify the end date of the Agreement between parties to be December 31, 2013.

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, CSI and the City agree as follows:

1. The term of the Agreement shall be amended to reflect an end date of the agreement to be December 31, 2013.

2. On December 31, 2013, CSI shall provide a detailed report to the City, listing individual transactions on each account. The report will include the following:

- i) Placement Balance of all assigned accounts;
- ii) Current Balance of all assigned accounts;
- iii) All payments made on assigned accounts;
- iv) Withholdings/repayments for Agency commission on all payments on assigned accounts; and
- v) Current account status of all assigned accounts.
