RESOLUTION NO 3424

**A RESOLUTION TO AMEND RESOLUTION 3341 BY ESTABLISHING NEW GOLF FEES TO BE CHARGED AND COLLECTED FOR PARK AND RECREATION GOLF ACTIVITIES; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Bryan provides facilities for and coordinates certain golf activities; and

**WHEREAS**, it is necessary to set certain fees for the reasonable use of golf facilities and coordination of activities; and

**WHEREAS**, it is necessary to set certain conditions affecting fees for the use of golf facilities and coordination of activities;

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRYAN:**

**SECTION I.**

That the fees charged and collected for golf activities shall be as follows:

RESOLUTION NO. 3443

A RESOLUTION TO AMEND RESOLUTION NO. 3424 BY SUPPLEMENTING RESOLUTION NO. 3424 SUCH THAT THE CITY MANAGER, OR HIS OR HER DESIGNEE, MAY DETERMINE GOLF FEES FOR WEATHER CONDITIONS, SPECIAL EVENTS, TOURNAMENT PLAY, MEMBERSHIP/RECRUITMENT CAMPAIGNS, AND MARKET RATES AND FEES THAT MAY REQUIRE FEES LOWER THAN THOSE IMPOSED THROUGH RESOLUTION NO. 3424; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Bryan operates the Travis B. Bryan Municipal Golf Course as a municipal golf course; and,

WHEREAS, the City of Bryan staff is responsible for coordinating certain golf events and ensuring the number of rounds played are as high as possible at the Travis B. Bryan Municipal Golf Course; and,

WHEREAS, it is necessary to set certain fees for the reasonable use of golf facilities and coordination of activities; and,

WHEREAS, some events, such as weather conditions, special events, tournament play, and market conditions, cannot be predicted; and,

WHEREAS, it is necessary to adjust and set fees to reflect certain conditions affecting the fees and coordination of activities for the use of golf facilities, including the Travis B. Bryan Municipal Golf Course.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRYAN:

**SECTION 1.**

Resolution No. 3424 remains in full force and effect with fees established through that resolution as the maximum allowable charge for golf fees.

**SECTION 2.**

Golf fees at the Travis B. Bryan Municipal Golf Course may be established or adjusted by the City Manager, or his or her designee, due to weather, special events, tournament play, membership/recruitment campaigns, and market rates and fees. Such fees may not be adjusted above the published fees as approved by the City Council.

**SECTION 3.**

This resolution shall be effective immediately upon adoption.
